Daycare Agreement  
Terms and Conditions

I, the legal owner(s) and guardian(s) of \_\_\_\_\_ (hereinafter 'my pet'), hereby agree to the following terms and conditions of my pet's participation in activities at A Dog's Life! Doggy Daycare & more...

1. I understand that A Dog's Life! Doggy Daycare & more...and its employees (hereafter collectively 'The Center') agree to exercise due diligence and reasonable care, and to keep the premises sanitary and properly enclosed.

2. I understand that despite the best efforts of the staff at the Center, those accidents can occur. Pursuant to this agreement and in consideration of the due diligence exercised by the Center, I hold the Center harmless for any liability with respect to loss or damage resulting from disease, theft, fire, death, escape, or injury to my pet. I further hold the Center harmless for harm to any person, other pet(s) or property by my pet.

3. I agree that the Center may seek veterinary care for my pet if such care is reasonably deemed necessary for the welfare of my pet. The Center agrees that they will make all reasonable effort to contact both the Owner (or Agent) and the treating veterinarian before seeking treatment. However, I agree that if such contact is not successful that the Center may take reasonable steps to ensure the health and safety of my pet until such contact can be made.

4. I hereby certify that my pet is in good general health and is clear of any contagious diseases or conditions. I certify that my pet will remain current on all vaccinations as set forth in the Center's rules and guidelines. I understand that I must provide veterinary proof of such vaccination both before my pet's first visit at the Center, and periodically as required when vaccinations are updated (generally, every year). I also agree that my pet will be maintained on a scheduled monthly flea/tick preventative for attendance at daycare. I understand that any pet arriving at the Center with fleas and/or ticks may be treated (including a bath and/or application of flea control) as appropriate at the Center's discretion, and that I will be responsible for any such treatment if required. I hereby give the Center permission to request any relevant records from my pet's treating veterinarian.

5. I hereby certify that my pet is of sound mental health and of a reasonable disposition. I agree to abide by the judgment and expertise of the Center with respect to handling any potential temperament concerns. I understand that if I can or will not follow any recommendations that may be made by the Center with respect to my pet's training or socialization that my pet may not be allowed further visits to the Center.

6. I agree to pay the rate for services that are in effect on the date that my pet attends any activities at the Center. Prices are subject to change at any time without notice, and it is my responsibility to ensure that I understand the applicable rate for my pet and the activity in question. I also agree to the following terms:

- **All fees must be paid in advance (upon check-in)**, and no pet will be released until all charges are paid in full.
- Cancellation fees may be applied for reservations cancelled less than 24 hours prior to a scheduled reservation (see Center Rules)
- All pets will be released only to the Owner or the Owner's registered agent. It is the Owner's responsibility to approve any agent.

- All pets must be picked up by 6:00 p.m., and a late fee of \$1.00 per minute will be charged in accordance with the Center rules for late pick up. It is understood any pet left after 6:30 will be transported to our boarding facility and charged appropriate boarding fees as well as any incurred late fees. The Owner will be responsible for all expenses relating to transportation, boarding and overnight care. Any pet left for over 24 hours without prior arrangement by the Owner or a registered agent will be considered abandoned, and the Center shall not be liable for the subsequent placement of the abandoned pet. By admitting my pet to activities at the Center, I grant the Center a lien on my pet for any and all unpaid charges resulting from services provided by, at, or through the Center, including but not limited to charges for boarding and placement/adoption.
- Pre-paid multiple-visit cards are non-refundable, unless we must request that your pet no longer attend the Center. Under these circumstances, you will receive a pro-rated reimbursement.

I further agree that I shall remain liable for all charges incurred for the care and maintenance of my pet at all times.

7. I agree that the Center's liability for my pet shall under no circumstances exceed the lesser of the current tangible value of a pet of the same breed and general condition (age, health, etc.) or the sum of \$200 per animal. I further agree to remain solely responsible for any and all acts or behavior of my pet while in the care of the Center.

8. I agree that my pet may be photographed, videotaped, or otherwise recorded, and that such recording shall be considered the property of the Center and as such may be used by the Center in any form of advertisement, including but not limited to publication on the Center's website. I understand that the Center will not use the recording for any purpose other than promoting the business of the Center without my permission.

9. I understand that the Center reserves the right to refuse services or admittance to any dog for any reason.

I understand and agree to the above conditions.
